## What kind of private data do we collect?

- While applying for an audition or a single private class: name, parent's name if you are a child, contact(s), age, residence, information about previous studies, demo material, information about circumstances of learning the instrument.
- While subscription on our newsletter: name, e-mail.
- While ordering tickets: name, e-mail, billing data.
- While signing a contract: place and date of birth, exact residence, billing data above the previously given data.
- While entering an exam: ID or Passport number.
- While attending classes or performing on our events: audio and video recordings.

## Where do we store your data?

We store all your data electronically, using a cloud system. Only the data for the contracts are stored also on paper, we store these data in Hungary and also handle it here.

## Who can access your data?

They are only the colleagues of Amirabilis Piano Bt. who are entitled to collect, store, view and handle your data. We never give, sell or exchange your data with third party outside of Hangrózsa Zongoraiskola. However we use external suppliers to be able to provide our services. External suppliers cooperate with us and handle data by their own regulations.

We use your private data for billing and for bookkeeping also.
- **For marketing tools**  
Audio and video recordings made during our private classes and events are published on our marketing channels and used for market achievements.

## What are your rights?

- **Right for access**  
You always have the right to claim for information about your given private data, please contact us to do so.
- **Right for correction**  
You always have the right to claim for modifying your private data as well as replace your missing data. Contact us to do so, your data for our newsletter can be modified in the footer of our newsletters.
- **Right for cancellation**  
You always have the right to claim for cancelling your private data excepting for those cases if we must keep those for purposes provided by law. Contact us to do so, you can unsubscribe from our newsletter in the footer of our newsletters.
